1 Introduction to Alexkor SOC Limited (“the Company” or “Alexkor”)

Alexkor was established in terms of the Alexkor Limited Act, No. 116 of 1992, and amended by the Alexkor Amendment Act, No 29 of 2001. The Company is listed as a Schedule 2 public entity wholly owned by the Government through the Minister of Public Enterprises as the shareholder representative. The Company has two business units, which includes the Pooling and Sharing Joint Venture (“PSJV”) and the Alexkor corporate unit.

The core business of the Company is the mining of diamonds on land, along rivers, on beaches and in the sea along the north-west coast of South Africa. These activities are complemented by geology, exploration, ore reserve planning, rehabilitation and environmental management.

The non-core business activities comprise of residential services, community services, outside engineering services, external transport services, guesthouses, a fuel station and an airport.

7 How to submit a request for access to records [Section 51(1)(e)]

7.1 Request procedure

To facilitate the timely processing of your request, the requester must kindly adhere to the following:

- 7.1.1 Complete the access request form at the end of the document in BLOCK LETTERS and submit this form together with the request fee.
- 7.1.2 Address the request to the contact person as indicated above as per his/her address, fax number, or electronic mail address.
- 7.1.3 Provide sufficient details to enable the Information Officer to identify:
- The record(s) requested;
 - The requester (and if an agent is lodging the request, proof of capacity);
 - The form of access required;
 - The postal address or fax number of the requester in the Republic;
 - If the requester wishes to be informed of the decision in any manner (in addition to written) the manner and particulars thereof;
 - The right which the requester is seeking to exercise or protect with an explanation of the reason the record is required to exercise or protect the right.
- 7.1.4 If the provided space on the form is inadequate, please continue on a separate folio and attach it to this form. Please note, the requester must sign all the additional folios.
- 7.1.5 The completed access request form with a copy of the identity document of the requester must be submitted via conventional mail, e-mail or fax.

7.2 Prescribed fees [Section 51(1)(f)]

The following applies to requests (other than personal requests *):

- 7.2.1 Payment and banking details can be requested from the Information Officer as indicated above and must be processed via electronic fund transfer.
- 7.2.2 A requestor is required to pay the prescribed fees (R57.00, incl. VAT) before a request will be processed;
- 7.2.3 If the preparation of the record requested requires more than the prescribed hours (six), a deposit shall be paid (of not more than one third of the access fee which would be payable if the request were granted);
- 7.2.4 A requestor may lodge an application with a court against the tender/payment of the request fee and/or deposit;
- 7.2.5 If a deposit has been paid in respect of a request for access which has been refused, the information officer concerned must repay the deposit to the requester;
- 7.2.6 If the request for access is successful an access fee will be required for the search, reproduction and/or preparation of the record(s) and will be calculated based on the Prescribed Fees;
- 7.2.7 Records may be withheld until the fees have been paid.
- 7.2.8 The fee structure is available on the website of the South African Human Rights Commission at www.sahrc.org.za.

7.3 Processing of requests

- 7.3.1 Alexkor SOC Limited will within 30 days of receipt of the request decide whether to grant or decline the request. Written reasons for declining a request will be given to the requester.
- 7.3.2 In the event of the request being voluminous, or the request requiring a search for information held at another office and/or the information cannot reasonably be obtained within the initial 30 day period, Alexkor SOC Limited will notify the requester in writing, should an extension be required.

* Note: Personal requests refer to any person seeking access to records that contain their personal information.

10 Grounds for refusal of access to records [Chapter 4]

- 10.1 Mandatory protection of the privacy of a third party who is a natural person, involving the unreasonable disclosure of personal information about that third party.
- 10.2 Mandatory protection of commercial information of a third party, if the record contains:
- Trade secrets of the third party.
 - Financial, commercial, scientific or technical information, that if disclosed could cause harm to the commercial or financial interests of the third party.
 - Information supplied in confidence by the third party to Alexkor SOC Limited, that if disclosed could put the third party at a disadvantage in negotiations or prejudice the third party in commercial competition.
- 10.3 Mandatory protection of certain confidential information of a third party, that if disclosed would result in a breach of confidence in terms of an agreement.
- 10.4 Mandatory protection of the safety of individuals and protection of property.
- 10.5 Mandatory protection of records privileged from production in legal proceedings.
- 10.6 Commercial information of Alexkor SOC Limited, which may include:
- Trade secrets
 - Financial, commercial, scientific or technical information, that if disclosed could cause harm to the commercial or financial interests of Alexkor SOC Limited.
 - Information, that if disclosed could put Alexkor SOC Limited at a disadvantage in negotiations or prejudice Alexkor SOC Limited in commercial competition.
- 10.7 Mandatory protection of research information of a third party and protection of research information of Alexkor SOC Limited.
- 10.8 Where a requester or third party is aggrieved by a decision officer in relation to a request for access to a record held by Alexkor SOC Limited, they may, by way of an application, within 30 days apply to a court for appropriate relief in terms of section 82 of the Act.

11 Appeal

Where a requester or third party is aggrieved by a decision of the Information Officer in relation to a request for access to a record held by Alexkor SOC Limited, they may apply within 10 days of notification of the decision, to the CEO of Alexkor who has 10 days within which to respond.
